Anita Wallgren, Arlington Neighborhood Village "Helping the Elderly Stay in their Homes"



Anita Wallgren began volunteering with the Arlington Neighborhood Village planning team in 2013 after more than 30 years' experience as a business executive, government attorney, and program director. Her career in media technology regulation led her to work at the Federal Communications Commission (twice), in diversified public companies in Cincinnati and New York City, and in a Silicon Valley media technology start-up company. She retired from the Federal Government after managing the TV Converter Box Coupon Program, to complete the nation's shift from analog to digital television.

Anita joined the ANV Board in September 2014 and served as Secretary through 2015. She was elected and served as President in 2016 and is completing her final year as President in 2017. Today, more than 190 volunteers serve more than 200 ANV members. Anita's goals are to help ANV become even more valuable to its members, more rewarding to its volunteers, and more financially sustainable. Originally from Grand Rapids, Michigan, Anita holds a J.D. and Bachelor's degree in Journalism Education from the University of Michigan. Anita lives in Virginia Square and embraces Arlington's "car-free" lifestyle.
